- (d) 根據《人事登記條例》(第177章)及其附屬規例,行使權力和 執行職務,包括按政務司司長根據《人事登記條例》第11條 所作的書面批准披露資料;

- The personal data furnished in the application will be used by Immigration Department, the Government of the HKSAR for one or more of the following purposes:
- to process your application for registration and application for an identity card under the Registration of Persons Ordinance (Chapter 177) and its subsidiary Regulations;
- to process your travel document application;
- to process other's application for immigration facilities in which you are named as a sponsor or referee;
- to exercise the powers and carry out the duties under the Registration of Persons Ordinance (Chapter 177) and its subsidiary Regulations including disclosure of information as permitted in writing by the Chief Secretary for Administration by virtue of section 11 of the Registration of Persons Ordinance;
- to administer/enforce relevant provisions of the Immigration Ordinance (Chapter 115), Immigration Service Ordinance (Chapter 331) and Hong Kong Special Administrative Region Passports Ordinance (Chapter 539), and to assist in the enforcement of any other Ordinances and Regulations by other government bureaux and departments through carrying out immigration control duties;
- to enable government bureaux, departments or other organisations to compile statistics for research purposes on the condition that the resulting statistics or results of the research will not be made available in a form which will identify the data subjects or any of them; and
- for any other legitimate purposes as may be required, authorised or permitted by law.

The provision of personal data (except optional items) is obligatory for registration under the Registration of Persons Regulations (Chapter 177A). Any person who without reasonable excuse, fails to comply with the statutory requirement shall be guilty of offences under the Ordinance. In addition, if you do not provide sufficient information, we would not be able to process your application.

### Classes of Transferees

The personal data you provide may be disclosed to government bureaux, departments and other organisations for the purposes mentioned in paragraph 1 above.

# Access to Personal Data

- You have a right to request access to and correction of your personal data as provided for in sections 18 and 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance (Chapter 486). Your right of access includes the right to obtain a copy of your personal data provided in this form subject to payment of a fee.
