## **Purpose of Collection**

- any other legitimate purposes as may be required, authorised or permitted by law. The provision of personal data in the process of the application is voluntary. If you do not provide sufficient information, we may not be able to process your application.

### Classes of Transferees

The personal data you provide may be disclosed to government bureaux, departments and other organisation for the purposes mentioned above.

### Access to Personal Data

You have a right to request access to and correction of your personal data as provided for in sections 18 and 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance (Chapter 486). Your right of access includes the right to obtain a copy of your personal data provided in this form subject to payment of a fee.
