Eligibility

- Chinese citizens who have either acquired the right of abode or been granted unconditional stay in Hong Kong; or
- Persons not of Chinese nationality who have been granted unconditional stay in Hong Kong but cannot obtain national passports h or travel documents of any other countries or regions.

Note: Under the "Easy Travel Scheme", holders of Hong Kong identity cards bearing "***, "*" or "R" symbol or locally issued Hong Kong permanent identity cards, who are aged 11 or over, can travel to and from the Mainland and Macau SAR through HKSAR without producing HKSAR Re-entry Permits or other travel documents at Hong Kong immigration control points. They are also not required to fill in arrival/departure cards.



Application Channel

In person

You must submit your application in person at any one of the offices listed at the back of the application form. Please produce the original copies of documents listed at (3) for verification.



Documentary Requirements and Fee

Documentary requirements

- Re-entry Permit application form (ID73);
- One recent photograph (The photograph should be taken in full face, without a hat. The background should be plain and of a light colour. The size must not be larger than 55 x 45 mm or smaller than 50 x 40 mm. The photograph will not be stuck onto the permit. It is used for reproduction of a digitised image. The quality of the image appearing on the permit will depend on the quality of the original photograph you have furnished.);
- Your Hong Kong identity card;
- Documentary evidence of your legal residence in the HKSAR (For new arrivals only);

Additional requirements (For applicants of the age of 16 or 17)

- Consenting parent or legal guardian's Hong Kong identity card or valid travel documents;
- Your birth certificate to prove the relationship between the consenting parent and you, or a court order, if appropriate, to prove that the consenting legal guardian has custodial rights in respect of you; and
- 7. If you are married, only marriage certificate is required. Parental or legal guardian's consent and items (5) and (6) are not required.

Fee

For the fee and payment methods, please see (4)



- If you are requesting a replacement of Re-entry Permit, your previous Re-entry Permit should be produced for cancellation upon submission of application.
- If your previous Re-entry Permit is lost, damaged or not available, you have to complete form ID645 obtainable at the offices listed at the back of the application form or downloadable at the website www.immd.gov.hk. The processing time may be longer.
- Additional documents or information may be required if necessary.
- An application with insufficient supporting documents will not be processed and will be returned to the applicant.

Fee is collected upon issue of Re-entry Permit. The up-to-date fees are shown in the Fee Leaflet (ID912).

Other Information

Validity

The Re-entry Permit good for a single journey is valid for 6 months. The multiple Re-entry Permit is valid for 5 years.

Take good care of your Re-entry Permit

Please keep your Re-entry Permit properly. Loss of Re-entry Permit takes time and money to replace. Do not easily entrust your travel document to a stranger. In the event of loss of your travel document outside Hong Kong you may contact our 24-hour hotline (852)1868 for assistance. If you have planned to travel to and from the Mainland and Macau SAR, please apply early.

- 供作統計及研究用途,但所得的統計數字或研究成果,不會 兀 以能辨識各有關的資料當事人或其中任何人的身份的形式 提供;以及
- 供作法例規定、授權或准許的其他合法用途。

The personal data provided in the application form will be used by Immigration Department for one or more of the following purposes:-

- to process your application;
- to administer/enforce relevant provisions of the Immigration Ordinance (Chapter 115); Immigration Service Ordinance (Chapter 331) and to assist in the enforcement of any other Ordinances and Regulations by other government bureaux and departments through carrying out immigration control duties;
- to process other person's application for immigration facilities in which you are named as a sponsor or referee;
- for statistics and research purposes on the condition that the resulting statistics or results of the research will not be made available in a form which will identify the data subjects or any of them: and
- any other legitimate purposes as may be required, authorised or permitted by law.

The provision of personal data in the process of your application is voluntary. If you do not provide sufficient information, we may not be able to process your application.

Classes of Transferees

The personal data you provide may be disclosed to government bureaux, departments and other organisations for the purposes mentioned above.

Access to Personal Data

You have a right to request access to and correction of your personal data as provided for in sections 18 and 22 and Principle 6 of Schedule 1 of the Personal Data (Privacy) Ordinance. Your right of access includes the right to obtain a copy of your personal data provided in the application form subject to payment of a fee.

With effect from 14 May 2019, the information relating to application for HKSAR Travel Documents is updated as follows:

1. **Processing Time:** The processing time of applications of HKSAR Passport or HKSAR Document of Identity for Visa Purposes after receiving all necessary documents, application fee and photograph is as follows:

Type of Application (Local Application)	Processing Time
First or replacement application	5 working days#
Children under 11 not holding a Hong Kong permanent identity card (applicable to passport applications only)	10 working days#

2. Application Form:

- a) An applicant may provide a contact telephone number which can receive Short Message Service (SMS) on the application form. SMS reminders in relation to the application will be sent to the telephone number.
- b) Visually impaired person may choose, by indicating in the "Additional Information" column of the application form, to apply for a Passport or Document of Identity for Visa Purposes with braille printing.
- **3. Supporting Documents:** Applicant needs not to furnish Hong Kong Birth Certificate, Hong Kong Marriage Certificate or Hong Kong Adoption Certificate issued by the Immigration Department as supporting document.
- **4. Self-service Kiosks:** Self-service kiosks are now renamed as "**Travel Document Submission Kiosks**". An applicant holding a valid Hong Kong Permanent Identity Card could submit his/her passport application at a Travel Document Submission Kiosk (except application due to damage/loss/amendment of personal particulars).
- **5. Online and Mobile Application:** An applicant holding a valid Hong Kong Permanent Identity Card could submit his/her passport application online or through the Mobile Application (except application due to damage/loss/amendment of personal particulars).

New enhancements for HKSAR Re-entry Permit

Starting from 1 April, 2022, eligible applicants can submit their applications for HKSAR Re-entry Permit by post or drop-in. After approval of the applications, the Immigration Branch Offices will inform the applicant to attend the selected office for payment and collection of HKSAR Re-entry Permit. If an applicant is under 16 years of age, he/she must be accompanied by his/her parent or legal guardian.
